- (1) 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。
Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.
- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -
- 第52(1)條 / Section 52(1)
在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。
A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.
- 第53(2)條 / Section 53(2)
如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。
If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.
- 第53(3)條 / Section 53(3)
如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。
If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase - (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.
- (4) 註：於本第(4)段內，「售價」指本價單第二部份表中所列之價錢，而「成交金額」指臨時買賣合約及買賣合約所載之價錢（即售價經計算適用折扣後之價錢）。因應不同支付條款及／或折扣按售價計算得出之價目，皆以向下捨入方式換算至千位數作為成交金額。
Note: In this paragraph (4), "Price" means the price set out in the schedule in Part 2 of this price list, and "Transaction Price" means the purchase price set out in the preliminary agreement for sale and purchase and agreement for sale and purchase, i.e. the purchase price after applying the applicable discounts on the Price. The price obtained after applying the relevant terms of payment and/or applicable discounts on the Price will be rounded down to the nearest thousand to determine the Transaction Price.

Upon signing of the preliminary agreement for sale and purchase, the Purchaser shall pay the preliminary deposit which is equivalent to 5% of the purchase price. HK\$100,000 being part of the preliminary deposit must be paid by cashier order(s) and the balance of the preliminary deposit may be paid by cheque(s). The cashier order(s) and cheque(s) should be made payable to "MAYER BROWN".
- (H) **現金或即時按揭付款計劃 - 120日成交：依照售價減 6%**
Cash or Immediate Mortgage Payment Plan - transaction completed in 120 days : 6% discount on the Price
- 成交金額5%：於買方簽署臨時買賣合約時支付，並於5個工作日內到賣方律師樓簽署正式買賣合約。
5% of the Transaction Price: shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase. The Formal Agreement for Sale and Purchase shall be signed at the Vendor's solicitors' office within 5 working days after signing of the Preliminary Agreement for Sale and Purchase.

5% of the Transaction Price: shall be paid by the Purchaser within 30 days after signing of the Preliminary Agreement for Sale and Purchase.

90% of the Transaction Price: shall be paid by the Purchaser within 120 days after signing of the Preliminary Agreement for Sale and Purchase.

150 Days Payment Plan - 3% discount on the Price

5% of the Transaction Price: shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase. The Formal Agreement for Sale and Purchase shall be signed at the Vendor's solicitors' office within 5 working days after signing of the Preliminary Agreement for Sale and Purchase.
 - 成交金額5%：於買方簽署臨時買賣合約後30日內支付。
5% of the Transaction Price: shall be paid by the Purchaser within 30 days after signing of the Preliminary Agreement for Sale and Purchase.
 - 成交金額5%：於買方簽署臨時買賣合約後90日內支付。
5% of the Transaction Price: shall be paid by the Purchaser within 90 days after signing of the Preliminary Agreement for Sale and Purchase.

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the Development:

- (a) 買方須繳付一切有關擬備、簽訂、完成、加蓋印花及登記住宅物業之臨時買賣合約、正式買賣合約及轉讓契的律師費和其他費用。
The Purchaser shall pay all the legal costs and disbursements of and incidental to the preparation, execution, completion, stamping and registration of the Preliminary Agreement for Sale and Purchase, Formal Agreement for Sale and Purchase and the subsequent assignment of the residential property.
- (b) 如買方同時聘用賣方之律師於住宅物業之正式合約及轉讓契及按揭契中代表買方，賣方將促使賣方的律師同意豁免收取買方須繳付給賣方的律師處理該項目中的指明住宅物業之正式合約及轉讓契的律師費。如買方選擇聘用其他律師代表買方處理有關之交易，買賣雙方須負責支付各自有關正式買賣合約及轉讓契兩項法律文件之律師費用。

The Purchaser shall pay all the legal costs and charges in relation to any other legal documents including but not limited to nomination and supplemental agreement, a due proportion of the costs for the preparation of the deed of mutual covenants and management agreement of the Development and the plans attached thereto, all costs for preparing certified copies of title deeds and documents of the residential property, all professional fees for the plans to be annexed to the Formal Agreement for Sale and Purchase and the subsequent assignment of the residential property in the development, all registration fees and other disbursements payable on the Preliminary Agreement for Sale and Purchase, Formal Agreement for Sale and Purchase and the subsequent assignment of the residential property and all legal costs and other costs and disbursements in respect of any mortgage (if any) in respect of the residential property, the costs of any statutory declaration required for application for exemption of buyer's stamp duty and/or higher rates (Scale 1) of ad valorem stamp duty, and all legal costs and charges of any other documents relating to the sale and purchase of the residential property.
